# "Rapid Expert Assistance and Co-operation for Conflict Prevention Operations, Crisis Management and Post-Conflict Rehabilitation"

Course Certified by the Institute of Human Rights of the Faculty of Law of the Complutense University of Madrid (Spain) and recognized by the Peace Operations Training Institute

The origin of this project was the Declaration of Santander 2001, which was adopted at a Conference held in Santander, Spain, with professors and students from 35 Universities from Europe, USA and Canada.

#### **OBJECTIVE**

Prepare international teams of participants, mainly postgraduate students, more than 24 years old, to work with the OSCE, UN, EU and other International Organizations in International Missions.

#### **GENERAL INFORMATION ABOUT THE COURSE IN NOVEMBER 2011:**

- General Contents of the Course: Human Rights and Fundamental Liberties, Democratization and Rule of Law, Conflict Prevention and Resolution, Crisis Management and Fieldwork Techniques.
- Dates and Places of the XV Course:
  - Dates of the XV Course: November 1<sup>st</sup> to November 30<sup>th</sup> 2011
    Note: students should arrive in Madrid on Sunday October 30<sup>th</sup>, as the group will travel together on the morning of Monday, October 31<sup>st</sup> to spend their first week of the course in a different location.
  - Location:
    - 1. First week away from Madrid. (From Monday October 31<sup>st</sup> to Saturday November 5<sup>th</sup>) Transportation, hotel and full board will be financed by Helsinki España during those days.
  - 2. Second, third and fourth week in the Helsinki España's Headquarters in Madrid. – Helsinki España will NOT provide or be responsible of your accommodation during the weeks spent in Madrid.
- Duration of the Expert Training: Intensive Course of 220 hours.
- Schedule: Mondays to Fridays from 8:30 AM to 18:00 PM. Saturdays from 9 AM to 14 PM.
- Student Requirements: Possess a university degree and a high level of English
- Number of students per course: Maximum of 25
- Language of the Course: The Courses will be offered in English due to the international character of the students and lecturers.
- Course Teaching Staff: The Courses will be taught by university professors from different countries, experts in the thematic contents of the course; trainers from the OSCE and the UN; diplomats and civil servants from the Spanish Ministries of Foreign Affairs, Defence and the Spanish Home office; the Red Cross and international experts in the missions of different international organizations.

- <u>Methodology:</u> The course combines theory and practice using debates, conferences, group work, seminars, case studies, fieldwork techniques and simulations.
- Registration fee: €350, which must be paid from the moment the student confirms his/her availability. This amount will be subtracted from the total tuition. No reimbursement will be granted to students who for whatever circumstance cannot attend afterwards.
- **Scholarships:** Helsinki España grants a limited amount of partial scholarships covering between 30% and 90% of the course tuition. They have to be requested by the interested candidate whom, along with the relevant documentation, must attach a copy of a recent payslip or income-tax-return.
- Tuition: €4.850 which covers:
  - Tutorship
  - Reading material
  - Diploma recognized by the Complutense University of Madrid and Helsinki España
  - Hotel accommodation, transportation and full board for the week spent out of Madrid. (From October 31<sup>st</sup> to November 5<sup>th</sup>).
  - Visits and transportation to the International Demining Centre of Hoyo de Manzanares (mine-awareness practice).
  - Four-wheel driving practice
  - First aid diploma (Spanish Red Cross)

Note: Board & lodging costs during the three weeks of the Expert Course in Madrid are NOT included. Helsinki España is not responsible of your accommodation during the weeks in Madrid.
